Add Korea memb. fee 79/80 paid cash US Dollars 330.— approx. sFr. 500.—.

Add Denmark and Case Western fee for 78/79 522.50 + 275 = 797.50.

As you can see some countries are expelled as they have not paid their membership fees for 3 years. Following countries and schools are in danger of being expelled if they have not paid their fees by the first day of next congress: Bern, Ireland and Puerto Rico.

This is according to IADS regulations chapter 7 section 2D, page 20, para-

graph II. According to recommendations of the Exec. comm of 79/80 and of 80/81 any school country which have not paid the fees for two consecutive years shall not have any voting rights at the general assembly. Following countries are endangering their voting rights at next years general assembly in Egypt: Geneva, Zurich, Bern, Basel, Kenya,

Ghana, Al Azhar, Canada, Puerto Rico and Valparaiso. If your student organization has recently paid the membership fee and the notice has not reached us yet, please disregard this warning.

Ad. II

According to IADS regulations chapter 7 section IC each congress participant pay sFr. 20 to the association. The per capita fee last year in Freiburg was 439.95. This year per cap fee from Utrecht is about 2500 sFr.

Ad. III

For 20 sFr. you can become a supporting member if your school or national student organization are not member of IADS. A supporting member will be put on the mailing list for the IADS publications and he would be eligible to participate in the different events and activities provided-mainly exchanges and congresses.

Last year there were only 9 supporting members, but we hope more people will contribute to make the organization economically sound. Per 5 sept there are 3 new supporting members, and a figure of 9 members (180 sFr.) is posted on the budget.

Ad. IV

Each country or school must use the IADS exchange application form if they are to organize student exchanges through the IADS program. Each application form costs 5 sFr. The income from application forms the last years have been approximately 500 sFr.

Ad. V

The balance sum mentioned by the later treasurer is sFr. 12075.77 this is per 2/7/80.

The total income of the IADS 80/81 is calculated to be 30335.77 sFr. The figures marked by a + might be higher at

the final financial rapport at the next IADS general assembly.

Ad. VI

Reimbursement for the executive is the largest expense post of the IADS. So far I have reimbursed past executive members of 78/79 sFr. 2238.01 and of 79/80 sFr. 3030.40. In approximate figure of reimbursement for the executive of 80/81 is calculated to be approximately 13000 sFr. The post of the executive Committee is honorary but necessary expenses incurred in the frame of work for the association shall be reimbursed by the association on submission of official receipts. The association shall finance one delegate to the FDI congress. This delegate, preferably an officer of the association, shall be that officer (preferably) who resides the closest to the hosting country. The expenses incurred by the officer should fall within the following framework:

1. Postage and stationary;
2. Telephone calls;
3. Travel to and from all official business meetings using "Student Rate" travel, or any other reduced rates applicable;
4. Any essential overnight accommodation, e. g. due to length of visit or travel distance.
5. 50 % of congress fee should be reimbursed by the CoCo; the other 50 % being paid for by the officer.
6. Any other expenses approved by the general assembly.

The expenses of the Central Office fall within this framework. It must be mentioned that during the past years many expenses have been paid personally by the officers. Also many receipts are lost, so an approximate figure of the officers personal expenses not reimbursed is about 5000 sFr.

Ad. VII

As the interest in Swiss banks is very low, and there are relatively many trans-

actions the total sum of our business transactions with our bank is 30 sFr. in favour of the bank.

Total expenses of the IADS 80/81 is calculated to be sFr. 18298.41. The expenses of the executive might become higher as the midyear executive meetings place is not decided on, yet.

If these figures are relatively accurate, the assets of the IADS by the end of june 81 will be 12128.36 sFr.

As you probably not know the change of sFr. here are some rates.
